Housing

Barriers for Dads -

- Eligibility calculations don't consider child support obligation for paying dads
- Reentry dads not eligible and are excluded from housing due to criminal record
- All housing services/resources very narrow for dads
 - o Considered single
 - Tax credit goes to CP/mom only
- No emergency/transitional housing for dads with kids
- Hours of housing organizations dads work 8 to 5, when they are open
- Costs due to housing shortage
- Lack of housing
- High cost of housing
- High interest rates make impossible to buy a house
- Not enough income and much goes to support their child
- Wages not keeping up with housing costs
- Being house poor
- Long waiting list for housing/housing funds
- General unavailability results in a hurry up and wait mindset
- Commerce grants don't find non-profits that work w/volunteer staff
- Unable to get kids from CPS without housing

What Government Can do Better -

- More funding for dads unique situations
- More funds for shelter and transition for dads with kids
- More help with first/last rent or camp move in costs
- Need to extend tax credits to Non-Custodial Parents /Dads
- Build affordable housing
- Convert old buildings to affordable housing so many office building vacant
- Remote work will free up office space to be converted into housing

- Co-locate affordable housing brings benefits
 - Other services
 - Childcare
 - Gardening
- Make all options accessible one place increase access!!!!
- Meet dad where they are at PM shifts don't work well with shelters
- Shorten the process and application
- Reduce red tape
- Need to include extend housing protections to reentry dads
- Those who have paid high rent and child support should be eligible to own a home
- Stop needing to make 3x rent to qualify
- Too many fees Washer/dryer fee, file fee, application fee, etc.
- 3x rent income requirement is too high change that
- Rent control
- Make sure affordable housing is truly affordable
 - Not just \$50 below market
- Shared housing give tax incentive for rather than just developers getting it
- Tax breaks to renter not the owner
- Solutions to shrinkflation corporate greed take away tax incentives
- Stop banks from predatory lending give to nonprofits
- Food and gas prices too high
 - \circ $\ \ \,$ Have grocery stores donate the expired food
 - Focus on food insecurity
